Ventura. About 4,800 commercial and noncommercial flocks in this area remain under quarantine and will be checked for END.

END does not pose a threat to humans or to food, but it is a foreign animal disease that is deadly for nearly all species of birds. END-infected birds may sneeze, gasp for air, or cough, and develop muscular tremors or paralysis. While some birds may have greenish, watery diarrhea, other infected birds may show no signs prior to death. Infected birds can spread the virus through their droppings or by secretions from their nose, mouth or eyes. The virus can stay alive for several weeks and can be carried to new sites on contaminated shoes, clothing, equipment, trucks, manure or even feathers. That is why bird and poultry movement is prohibited from the quarantine zone, and trucks, equipment and other items must be disinfected prior to movement. Everyone must comply with quarantines.

In addition to complying with movement restrictions, bird and poultry owners can protect their flocks by practicing good biosecurity:

- \* Report unusual death losses or illness in the flock to their veterinarian, or state department of animal health.
- \* Don't keep pet birds on commercial poultry operations. Employees must not maintain their own birds or poultry, as they could carry bacteria or viruses from their birds to the commercial flock.
- \* Disinfect tires and the undercarriages of all vehicles as they enter or leave the farm or premise (no 'germs out').
- \* Disinfect footwear prior to entering or leaving poultry houses. Wear clean clothes when working with birds.
- \* Avoid visiting other poultry operations. Dangerous bacteria and viruses can be transported from one farm to another
- \* Know the health status of the flocks when buying new birds. Keep new birds segregated for 30 days prior to adding them to a flock.
- \* Maintain good records on purchases and sales. If a disease problem arises, these documents can help animal health officials track and eradicate disease.

## **Alert! Exotic Newcastle Disease**

Spreads from California to Nevada 8

On January 16th, Nevada officials announced that Exotic Newcastle Disease (END), a foreign animal disease deadly to birds and poultry, has been confirmed in a flock of 30 chickens near Las Vegas. Since October 2002, when it was detected in the U.S., the outbreak of this highly contagious viral disease had been confined to Southern California. Animal health officials are warning bird and poultry owners to comply with movement prohibitions on birds and related products from the uarantined areas in California and Nevada.

"This disease is a dire threat not only to the poultry industry, but also to poultry conservationists and fanciers," asserts Donald Bixby, DVM, Director of Technical Programs for the American Livestock Breeds Conservancy. "We could see this parallel the disaster of Foot and Mouth Disease in the UK if it is not brought under control."

To stop the spread of disease, state and federal regulatory personnel have imposed restrictions on the movement of birds and poultry products in an affected area. END-infected and exposed birds and flocks must be euthanized and disposed of properly. The premises then must be thoroughly cleaned and disinfected to ensure the virus has been killed.

A task force of more than 700 state and federal animal health employees from across the country are battling END in Southern California, where the federal quarantine has been expanded to eight counties. Nearly 1,250 noncommercial flocks and five commercial poultry operations in this area have been infected or exposed to END. Southern California counties currently included in the quarantine area are Imperial, Los Angeles, Orange, Riverside, San Bernadino, Santa Barbara, San Diego and

### Agricultural Education Program

A Vision for Utah Agricultural Education - All Utah citizens will have an appreciation for agriculture and the environment. Agricultural Education students will develop essential career preparation skills through technical and experiential education as well as personal leadership opportunities. The Mission of Agricultural Education - The mission of the Agricultural Education Program is to prepare students for employment and/or continuing education opportunities in agriculture through technical instruction in the classroom, experiential education through the laboratory and the Supervised Agricultural Experience Program, and leadership and personal development through the FFA.

FFA - The FFA is an integral and necessary component of the overall program. The FFA is dedicated to making a positive difference in the lives of young people by developing their potential for premier leadership, personal growth, and career success through agricultural education. The FFA has 457,278 members in 7,312 chapters across the nation with approximately 3000 of those members located in Utah in 65 chapters. Approximately 35% of the FFA membership in Utah is female. More than 850 FFA members attend our annual State FFA Convention and bring over 200 parents, advisors, school administrators, and guests. Over 51,000 members and guests attended the 2002 National FFA Convention.

Supervised Agricultural Experience Program - The supervised agricultural experience program (SAEP) is an integral and necessary component of the agricultural education program. Here students apply, in real life situations, the concepts that they learn in the classroom and the laboratory. At the entry level the SAEP can be exploratory in nature but as the student progresses in the program, the SAEP should become more occupationally oriented. Quality SAEP are identified by the following characteristics; supervised year-round by the agricultural education teacher, records are kept by the student, and a personal investment of time, energy and/or money are included and essential.

Career Preparation and Economic Development - American FFA Degree: 52 Utah FFA members earned the American FFA Degree in 2002

To receive this recognition students must have earned and invested at least \$7,500 in an SAEP. This group reported total earnings of \$1,274,233 for an average of \$24,504 per student. Over the past six years this premier group of 262 students has reported total earnings of \$7,089,116. State FFA Degree; Over 200 students earned the State FFA Degree in 2002. To receive this recognition students must have earned and invested at least \$1,000 in an SAEP. SAEP; In 1997 the combined total earnings for the American and State FFA Degree recipients was \$2,412,973. This small group of students represents just 8% of Utah's FFA membership and 2.5% of the total number of students enrolled in agricultural education classes. You do the math, agricultural education, FFA, and SAEP is an unrivaled tool for preparing students for employment and/or continuing education opportunities, leadership development and personal growth.

The State of Our Nation's Youth is an annual national survey of the attitudes and beliefs of typical American teenagers conducted by the Horatio Alger Association. The 1999 report was used for comparison in a Purdue University study, which identified the differences and similarities between the typical high school student, as identified in the study, and agricultural education-FFA students. The results of the study indicated that agricultural education students who are also FFA members possess attitudes and exhibit behaviors indicating they benefit more from their personal, academic and career experiences during school than the general student population. This theme is supported by three key messages and corresponding data:

FFA members are more enthusiastic about and attach greater value to their school studies than the average student.
FFA members are more actively engaged in school and community activities. (90% of FFA members vs. 77% of typical students.)
FFA members are more likely to believe that the harder they study the more opportunities they will have after graduation.
FFA members felt that their agriculture courses were much more challenging, interesting and exciting than typical students felt about their classes in general.

FFA members are more likely than the average student to relate personal effort to success and believe it is important do their best.

FFA members are more likely to believe the amount of work they do in school is important to their success later in life. (91% vs. 66% of typical students.)

FFA members are more likely to believe it is important to do their best in all of their classes. (93% vs. 73% of typical students.)
FFA members are preparing for post-secondary studies in slightly higher numbers and have more sharply defined career objectives than the average student.

FFA members are slightly more likely to attend two-year and four-year colleges. (86% of FFA members vs. 84% of typical students.) FFA members are much more likely to identify a career goal in agriculture.

FFA members are more likely to identify a specific career rather than a general field.

FFA members are more likely to be employed while in high school. (86% FFA members vs. 61.5%.)

### 100 Scholarships of \$1,500 each

The Commitment to Agriculture Scholarship Program, sponsored by Monsanto and the American Farm Bureau Foundation for Agriculture, offers high school seniors from farm families assistance with college expenses. To be considered for a scholarship, a student must:

- 1. Be a high school senior enrolled in the United States
- 2. Have family actively engaged in production agriculture
- 3. Not have a family member employed by Farm Bureau or Monsanto
- 4. Plan to pursue a career in agriculture
- 5. Enroll in a college or university for the fall semester of 2003
- 6. Have an average or above average academic record

An impartial selection committee composed of agricultural educators and agribusiness people (excluding the sponsors) will select 100 winners. In evaluating the applicants, the committee will consider leadership in community and school activities, involvement on the farm and responses to essay questions.
