

## Got too many white flies, mites, and other problems in your greenhouse?

- Get rid of weeds underneath your benches, in your pots, and adjacent to your greenhouse.
- Also dispose of all infested plants. Mites love weeds, ivies, roses, carnations and dianthus, foliage plants, etc. and they can crawl from pot to pot across drip systems.
- White flies have a fondness for Poinsettias, tomatoes, cineraria, Pick-a-Back plants, and basically any fuzzy leafed plants. (Plants with pubescence)
- Any one white fly or mite is too many and control needs to be done immediately.
- Use appropriate and registered chemical controls (approved for the specific situation and greenhouse) if chemicals are warranted.
- In summer time when there is nothing in the greenhouse, consider closing it down completely and allow it to heat up in order to control weeds, their seeds, and the insects that accompany them. This is another mechanical way of controlling pests.
- As you shut down for the summer, remove all plants and plant litter, old pots, trays, and spilt soil from the greenhouse. This is also a good time to weed in and around your facility. After weeding all you can, use a spray such as Roundup for and young or small weeds that remain. Be diligent and continue your attack throughout the summer whenever they appear.
- Remove any weed seed from your benches (especially the clover-like oxalis plant, which launches its projectile seeds throughout the greenhouse into pots and on benches), by spraying them down and disinfecting them with a disinfectant using a stiff scrub brush. Weed seed will wash down and should you have soil or gravel underneath your benches, the weed seed will germinate over a period of time. I suggest that you water the area where weed seeds may be lodged and get them germinated. Once they have germinated, you can spray them with a weed killer. You may be required to repeat this process several times.
- Remember to be diligent on weed control throughout the year even when there are projects underway in your greenhouse. I find it especially useful to be able to use student labor for such things as weeding. (Students who have either a deficit attendance wise, or may have missed an assignment that cannot be made up, find it extremely beneficial to have the opportunity of weeding for me).
- Finally, make sure that you clean and sterilize in between each crop. This will control
  insect and weeds.
- Enjoy a clean greenhouse!

Former National FFA Officer and Agriculture Teacher Named Chief Operating Officer for the National FFA Organization

Doug Loudenslager has been selected to become chief operating officer for the National FFA Organization and the National FFA Foundation.

Loudenslager's roots in FFA and agricultural education run deep. Bom and raised on a crop and livestock farm in Marion County, Ohio, he was a student of vocational agriculture and served as state FFA treasurer in 1973, an office his father held 20 years earlier. While a student at The Ohio State University, Doug was elected National FFA Eastern Region Vice President for 1975-76.

After graduating from Ohio State with a Bachelors of Science degree in agricultural education, Loudenslager began his career as a teacher of vocational agriculture at Cory-Rawson High School in northwest Ohio. He quickly rebuilt a lagging program, with many of his students receiving state and national recognition. His wife, Barbara, was a vocational teacher in home economics, also at Cory-Rawson.

Loudenslager garnered considerable experience in the industry of agriculture. He served as communications manager for the Ohio Farmers Grain and Supply Association (a regional grain and supply cooperative) and as executive director of the Ohio Soybean Association. During his time with the Ohio Soybean Association, Loudenslager organized and carried out numerous education, public relations and lobbying efforts.

Holding a Masters in Business Administration degree from Washington University, St. Louis, Missouri, Loudenslager brings solid business management experience to FFA. Since 1987, he has been employed by Edward Jones Investments headquartered in St. Louis, Missouri. With Edward Jones, he has held various positions including investment representative, full service account manager, new investment representative trainer, and area manager. Currently, he leads the Van Wert office, where he is responsible for managing \$265 million in assets and over 3,200 client relationships.

While in St. Louis, Loudenslager completed coursework through Asbury Seminary. He is a member of the Van Wert Rotary Club, First United Methodist Church, Defiance District UMC Strategy Team, the West Ohio Conference United Methodist Church Capital Campaign and the Ohio State University Alumni Advisory Committee. He served as president and board member of Rotary clubs in two communities.

The Loudenslagers are proud parents of three children. Jennifer is a recent graduate of Wilmington College with a degree in elementary education. David is a sophomore at The Ohio State University. Christopher will be in the 8th grade. His wife, Barbara, is also a graduate of Ohio State with a degree in home economics education.

Loudenslager will report to the National FFA Center June 28 and officially assume the duties of chief operating officer July 21.
